J. Motion 11.27.61 - Approve Shayne Thacker to be paid at the full rate vs. the reduced rate for Winter Cheerleading based on number of participants.


K. Motion 11.27.62 - Approve for/against committee appointment for upcoming Education Programs and Operations Levy.
